Animal feed trade overview



- In the main, feed is a low risk product
- UK is a significant market for Irish feed
- Trade in animal feed between Ireland and the UK increased c.22% from 2015 – 2020



Step 1: What importers must do?

- Companies/individuals must be registered with the Department
- Imports from Third Countries must be pre-notified to the Department at least 24-hours in advance
- Import Notification Form to be used other pre-notifications may also be required
- Third Country Representative required

Step 2: What else must importers do?

- Product names for feed additives and feed materials must be listed as well as trade names for compound feeds
- Additional requirements for the import of specific high risk feed from certain Third Countries (groundnuts)
- Importers must distribute relevant import notices to storekeepers



Role of Third Country Representatives



- Third Country Representative role is to ensure equivalent feed production conditions are met
- Feed Business Operators wishing to export to EU must ensure their feed has been produced in accordance with EU feed legislation
- To export feed into the EU a business must have a Third Country representative registered within the EU


Requirements for Third Country Representatives

- In Ireland, the Third Country Representative must be a registered Feed Business Operator.
- Third Country Representative must maintain adequate records that feed being produced and imported meets all EU feed legislation
- The Third Country Representative must have an active, staffed and physical premises - not just a postal address




Use the gold magnifying glass search tool



How to use the search facility?




Input 'trade in feed' into the search box

Sort the results by choosing the 'publications' category on the right




